- JV presented revisions/updates to the RUSD Website to better inform the community, such as CBOC application forms and Measure R 2006 project status update location (child in a yellow construction hat). JV will continue to work with Gina Ward (RUSD) to keep the RUSD
- KD suggested a notification system be implemented for the RUSD Website updates for the community. Both a Press Release and an Annual Report Release were discussed as viable solutions.
- BW mentioned that the District is watching the following financial issues:
 - 1. Interest Rate on selling Bonds:
 - Recent Bonds in other facets were attempted to be sold at a 6.9% interest rate and could not sell.
 - 2. Arbitrage on Bond funds:
 - There is a taxation of Bond funds that are not spent in a certain period of time.
 - JV explained that the taxation is typically paying back interest funds beyond a certain percentage. This is not necessarily a bad thing for the District, but it would be beneficial if it is avoided.
 - Construction and major use of funds is expected to begin by Fall 2009.
- In the future, CBOC Members requested reports, such as the Audit reports, be sent to them prior to the meeting for preliminary review.
- BW requested that existing CBOC members consider re-applying for another term on the CBOC. BW noted that one position will be opening up assuming all other members re-apply to maintain their membership status. EH will post the updated CBOC Member application on the RUSD Website.
- The process of CBOC Member approval was noted as such:
 - 1. BW reviews applications for approval.
- 2. The Superintendent and Board President make a recommendation to the Board for
 - 3. The Board approves the members.
